



## 2010 Sponsor Agreement

This signifies an agreement between the Down East Girls Softball League (herein called the League) and \_\_\_\_\_ (herein called Sponsor).

The agreement recognizes a donation consisting in the amount of \$\_\_\_\_\_, which becomes the property of the League for use in purchasing supplies, equipment, and any other items that would aid in the participants of the League in activity pursuing the game of softball during District Tournament.

The advertising categories are as follows:

- ❖ **Diamond** - \$1,000 donation: full page Program advertisement, 1 framed Certificate of Recognition, 8 tournament passes, 4 copies of the Tournament Program, Commensurate listing on DEGSL web site and in local newspaper, 1 4' x4' fence sign for the next season
- ❖ **Gold** - \$400 donation – full page Program advertisement, 1 framed Certificate of Recognition, 8 Tournament passes, 4 copies of the Tournament Program, Commensurate listing on DEGSL web site and in local newspaper
- ❖ **Silver** - \$200 donation – ½ page Program advertisement, 1 framed Certificate of Recognition, 4 tournament passes, 2 copies of the Tournament Program, Commensurate listing on DEGSL web site and in local newspaper
- ❖ **Bronze** - \$100 donation: ¼ page Program advertisement, 1 framed Certificate of Recognition, 2 tournament passes, 1 copy of the Tournament Program, Commensurate listing on DEGSL web site and in local newspaper
- ❖ **Friend of the DEGSL** - \$50 donation – 1/8 page Program advertisement, 1 framed Certificate of Recognition, Commensurate listing on DEGSL web site and in local newspaper
